The **first item** of business will be the reading, correction and approval of the minutes from the August 3, 2026, meeting.

The **second item** of business will be the rezone request of Zachary Linsky of Sullivan Development, LLC, on behalf of North Highway 3 Property, LLC. They would like to rezone parcel #40-09-21-300-035.000-004 located at 3075 N State Highway 3, North Vernon from Agricultural to Residential Multi-Family for a proposed approximately 50-unit, multi-family housing development.

Recommendation of the Essential Service Committee:

After a discussion with Zachary Linsky of Sullivan Development, LLC, Ed Biehle made the motion to approve the rezone. Jerry Shepherd seconded the motion. This passed unanimously with 6 members voting in favor. The Area Plan Commission will hear the request at their August 3, 2026, meeting.

After discussion with Zachary Linsky and several neighbors, Dave Woodall made the motion to deny the rezone. Scott Smith seconded the motion. The motion failed due to the lack of a quorum, with 4 members voting in favor of denial and 2 members abstaining. This request will be heard again at the Area Plan meeting at their September 9, 2026 meeting.

The **third item** of business will be the rezone request of Shawn Moore. He would like to rezone parcel #40-12-02-330-023.000-013 located at 119 N. Pike Street, Vernon from Residential Single-Family to Residential Multi-Family. The applicant requests this change to convert the existing detached garage into a secondary residential living space.

This passed with 4 members voting in favor and 1 member (John Post) voting to deny. The Area Plan Commission will hear the request at their September 9, 2026, meeting.

The **fourth item** of business is the rezone request of Jeremy Ochs of Vida Investment Group LLC. He would like to rezone parcel #40-09-29-100-018.000-004 located at N. State Highway 7, North Vernon from Commercial to (PUD) Planned Unit Development. The rezone is to allow for future development in the City of North Vernon.
